**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nikam Dabu on **24/01/2023** filed an RTI application under Form-‘A’ before the PIO-cum-Project Director, DRDA, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02/03/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17/04/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 316/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 8 (eight) times i.e on 05/06/2023, 04/05/2023, 16/10/2024, 04/12/2023, 22/01/2024, 08/04/2024, 12/06/2024 and 31/07/2024. In this hearing of the appeal on 31<sup>st</sup> day of July, 2024, appellant present but PIO found absent, however, he detailed his representative namely Shri Margo Hai, APIO. The APIO has intimated to the Commission that the information as sought by the appellant has already been provided to him in pen drive and hard copy also and submitted receipt copy of the documents before the Commission.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
