JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Ashok Sangbia on **24/01/2025** filed an RTI application under Form-'A' before the PIO-Cum- EE, (PWD Rupa Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **11/07/2025**, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/08/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-655/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st hearing on **20th Jan'2026**.

Details of information sought by the Appellants:

- a)** Category of work charged (W/C) serving under your division and sub-division.
- b)** Appointment letter of all the W/C staff serving under your division and sub-division.
- c)** Place of posting of all the W/C staff serving under your division and sub-division.
- d)** Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.
- e)** Present strength of W/C staff under your division and sub-division.
- f)** New strength of or against retirement or vacate of W/C staff under your division and sub-division.
- g)** Total sanction strength of W/C staff under your division and sub-division.
- h)** Recruitments rule (RR) of W/C staff serving under your division and sub-division.

Period for which information asked for:-2018 to till date

In the **1st hearing held on 20th Jan'2026**, related to the APIC No. 655/2025. The Appellant Shri Ashok Sangbia present during the hearing and PIO's representative Shri P.N Khirmey Assistant Engineer (AE) who is also the APIO present during the hearing with an authorization letter from the PIO-cum Executive Engineer PWD (Highway)Rupa Division .

Heard the Appellant.

The Appellant stated before he Commission that among the information that he has sought from the PIO all the information have been provided to him except the information sought in Sl.No. D & H of his form 'A'.

Heard the APIO;

The APIO stated that all the information have been provided to the Appellant and posted through registered post on 12/06/2025 and regarding the information stated as not provided pertaining to Sl No. B,D & H of the form "A" of the Appellant it has been clearly stated in the reply to the Appellant that the information are not available (NA) with the office of the PIO-cum EE Hydro Power Rupa Division as the EE doesn't appoint staffs but all the staffs are deputed by PWD and therefore, they have no separate recruitment rules for appointing WC staff and therefore, they do not conduct any interview or any viva voce and exam for appointing staffs. And so the information as sought by the Appellant and as available with the PIO have been furnished to the Appellant completely.

After hearing both the parties the Commission hereby decide;

Seeing the information furnished by the PIO to the Appellant the Commission is also satisfied by the statements of the PIO that all the information those are available with the PIO have been provided to the Appellant.

Pursuant to the above observation the Commission hereby orders;

- i) As information have been completely provided to the Appellant the Commission does not find any wisdom in further hearing of this appeal and therefore, this appeal is disposed of and closed once for all.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
