**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC- 738/2025.**

**APPELLANTS**

: Shri Gollo Takar, Lekhi near DTO office.

**RESPONDENT**

: The PIO, o/o the Dera Natung Govt. College Itanagar.

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Gollo Takar for non-furnishing of below mentioned information by the PIO, o/o the Dera Natung Govt. College Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 21.02.2025:

**Details of information required:**

1. CTC of the college admission fees structure of B.A, B.com and B.sc 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> Semesters and 2<sup>nd</sup>, 4<sup>th</sup>, & 6<sup>th</sup> Semesters from the year 2018-19 to 2024-25;
2. CTC of the Balance Statements after expenditures of college bank account for each financial year, from the year 2018-19 to 2024-25;
3. CTC of the fees submission to the DHTE for academic session 2019-20;
4. CTC of the fees submission to the RGU of 1<sup>st</sup>, 3<sup>rd</sup> & 5<sup>th</sup> Semester and 2<sup>nd</sup>, 4<sup>th</sup>, & 6<sup>th</sup> Semester from the year 2018-19 to 2020-21 and
5. CTC of the Staff under the college management with their designation appointment order, joining report and remuneration, for the year 2018-19 to 2024-25.

**Brief records emerging from the appeal:**

Records in the appeal reveal that the appellant had requested for the aforementioned information from the PIO but failed to obtain the same which prompted him to file his 1<sup>st</sup> appeal under section 19(1) of the RTI Act before the Director, Higher & Technical education, Govt. of A.P. ESS Sector, Itanagar, the First Appellate Authority (FAA) vide his memo of appeal dt. 17.04.2025.

Records also disclose that the FAA heard the appeal on 11.06.2025 and vide order dt.13.06.2025 disposed of the 1<sup>st</sup> appeal as under:

**"ORDER**

*This order shall dispose off the appeal received in this office on 28.04.2025 i.r.o. RTI Appeal ID No. 164.*

*Hearing Notice was issued on: 04.06.2025 and appearance on 11.06.2025.*

*On the date of hearing the appellant Shri Gollo Takar was present and PIO, DNGC, Itanagar was exempted from appearance.*

*The matter was heard. On perusal of records/statements, it was found that the information sought under RTI application was provided to the applicant except the 'Bank Account Statement of the College and duly received by the applicant. Since, the copies provided to applicant were not counter signed and stamped, thus, PIO is advised to provide the duly signed and stamped copies to the applicant.*

However, the request for providing "Bank Account Statement of the College is not considered in the light of section 8 (e) and section 8 (1) respectively of the RTI Act. 2005 as its disclosure does not serve any larger interest of the public. Also, the said account does not warrant Section 4 (xii), (xiii) as it does not have any subsidy and or concessions.

*In view of the above, the appeal stands disposed off and ordered accordingly.*

*If the applicant is not satisfied with this order/information provided he may file an appeal before the State information Commission, ESS Sector, Itanagar within stipulated period of time from the date of issue of this order*

The appellant, however, apparently, dissatisfied with the order of the FAA as above, preferred his 2<sup>nd</sup> appeal before this Commission under Section 19(3) of the RTI Act 2005 vide his memo of appeal dt. 08.09.2025.

**Hearing and decision:**

This appeal is, accordingly, listed for hearing today on 30.01.2026 wherein the appellant, Shri Gollo Takar and Dr. Shri Kumar Tok, Vice Principal, the PIO o/o the Principal Dera Natung Govt. College are present in person.

Heard the parties.

The appellant, reiterating his demand for the requested information/documents from the PIO, pleaded for an appropriate direction to the PIO to furnish the information. The PIO, on the other hand, submitted that the documents/information as sought for by him has already been provided except the Fee Structure of the College which are available in the web site.

Upon hearing the parties, this Commission noticed that the PIO had furnished appellant with the Fee Structure of UGC {Sl.No.(a)}, Fees submitted to the DHT for academic Session. 2019-20 {Sl.No.(c)} and copy of Fee submitted to RGU of all Semester 2021-24 {Sl.No.(d)} but did not furnish the Copy of College admission fees structure of B.A, B.com and B.sc 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> Semesters and 2<sup>nd</sup>, 4<sup>th</sup>, & 6<sup>th</sup> Semesters from the year 2018-19 to 2024-25 and copy of balance statements after expenditures of college bank account for each financial year, from the year 2018-19 to 2024-25.

As regards the query at Sl.No.(e), the query is vague and not specific as it does not mention clearly the category of staff, whether teaching or non-teaching staff/Ministerial staff. As such no direction could be issued to the PIO. However, the appellant shall be at liberty to file fresh RTI application before the PIO mentioning specific query/point.

This Commission, upon hearing the parties and in the light of above observation directs the PIO to provide the appellant with the following information documents:

- a) Copy of College admission fees structure of B.A, B.com and B.sc 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> Semesters and 2<sup>nd</sup>, 4<sup>th</sup>, & 6<sup>th</sup> Semesters from the year 2018-19 to 2024-25 and
- b) copy of balance statements after expenditures of college bank account for each financial year, from the year 2018-19 to 2024-25.



The PIO shall comply with the above direction within 3(three) weeks from the date of receipt of this order and the appellant shall, thereafter, within one week, intimate this Commission of the receipt of the same failing which this appeal shall stand closed.
