The appellant file a RTI Application dated 26/08/2024 seeking Details regarding Protection work, river channelization at Namchuk Habi Bordumsa (under RE 2023-24)

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 04/10/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Lajamang Mannow absent.

Respondent : PIO-cum-EE(WRD), Bordumsa Division absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Chow Lajamang Mannow on **26.08.2024** filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Bordumsa Division, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **04.10.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **20.12.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 446/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 21/05/2025 and 11/08/2025. In this hearing of the appeal on 11th day of August, 2025, both the parties, the PIO-cum-EE(WRD), Bordumsa Division, Changlang District and the appellant Chow Lajamang Mannow found absent without any intimation to the Commission.

As per the order dated 21/05/2025, PIO agreed to provide the information within 20 (twenty) days.

The appellant was also directed to intimate to the commission after receipt of the information on or before next date of hearing and it was also warned to the appellant that if no intimation was made to the Commission, it will be deemed that the information was provided by the PIO and the appellant is satisfied by the information provided.

Today both the parties are absent, the appellant has not made any intimation to the Commission as per the direction given in the last order, therefore, the Commission deems that the appellant has been provided the information as sought by him and he is satisfied.

The commission, therefore, deems fit to dispose of this appeal case and accordingly this appeal case is disposed of and closed.
