**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P. O/o BDO Along (East) CD Block, Aalo, West Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/01/2023 regarding expenditure & implementation under MG-NREGA/ Supply work / Pending work / New work / Sanction order/ Compete work.

**The 2<sup>nd</sup> hearing is held today on 17<sup>th</sup> October, 2023 as scheduled.** The SPIO-cum-BDO, Govt. of A.P. O/o BDO Along (East) CD Block, Aalo, West Siang District, Arunachal Pradesh is represented by Shri Domin Loya, EO (RE) and the Appellant Shri Tania June is found absent. On inquiry about the reason about his absence during the 1<sup>st</sup> hearing he has submitted that during that period there was no BDO in the Headquarter and present BDO is newly posted. Earlier there was no SPIO at Aalo. Further, he has furnished all the information as sought for by the Appellant through the speed post on 25/08/2023 and has confirmed the receipt of the information by the Appellant over phone.

In compliance with the directions of the commission, the SPIO has furnished the information to the Appellant on 25/08/2023 and the Appellant has confirmed the receipt of the same. The Commission could not hear from the Appellant as he is absent. The absence of the Appellant inspite of strict directions to appear before the Commission without fail, it shows that he is fully satisfied with the documents so furnished.

In consideration of the submission of the SPIO with evidence of furnishing the information and absence of the Appellant the case is disposed of and closed.
