**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tabit Nyigang, F-Sector, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-District Medical Officer, Govt. of A.P., Boleng, Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/03/2023 regarding detail list of PHCs (includes Sub Centers / CHCs) along with details list of Group-C, MTS (technical and non-technical) under Medical Department of Siang District, Arunachal Pradesh.

**The 2<sup>nd</sup> hearing is held today on 28<sup>th</sup> November, 2023 as scheduled.** Dr. Tarik Talom, the SPIO-cum-District Medical Officer, Govt. of A.P., Boleng, Siang District, Arunachal Pradesh is represented by Shri Tagong Tag, Dealing Assistant. The Appellant Sri Tabit Nyignag is absent. The APIO has submitted that he has brought information as sought for to be handed over to the Appellant in the court room, as the Appellant is absent he could not hand over the information. The commission directed the APIO to contact the appellant and furnish the information to the appellant. The Appellant is directed to visit the office of the PIO and collect the information.

In the 1<sup>st</sup> hearing held on 10<sup>th</sup> October, 2023 a clear warning was pronounced that if the PIO remains absent on the next date of hearing, the commission shall impose penalty under section 20(1) of the RTI Act on the SPIO and in case the Appellant remains absent the case shall be disposed of without further notice, presuming that the Appellant is satisfied with the information furnished by the SPIO.

Therefore, the case is hereby disposed of with liberty to the Appellant to apply a fresh application to the PIO if required.
