ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the District Fishery Development Officer, Yupia, Papum Pare District (A.P) as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 02.09.2024.

a) Particulars of information: Development of Fish Pond cum Piggery (Integrated development & management of Fishery) at Mabiaso, Papum Pare District (A.P).

- 12. Asset creation Registered;
- 13. Beneficiaries signed registers;
- 14. Details seeking documents with CTC and if any document are unavailable then clearly specify the reason for unavailable.
- c) Period for which information asked for: 2020-2021

The records reveal that the Appellant, Ms. Bengia Mama had filed application dated 02/09/24 before the PIO o/o the District Fishery Development Officer Yupia, Papum Pare District, Arunachal Pradesh requesting for information(s) regarding Fish Pond and Piggery (Integrated Development and Management of Fishery) at Mabiaso Papum Pare District (A.P).

Having failed to receive the information(s) from the PIO, the Appellant had filed First Appeal under Section 19(1) of the RTI Act, before the Appellate Authority (FAA), the Director (SJETA), Banquet Hall, Itanagar, AP, vide Memo of Appeal dated 21/10/24.

However, having failed again to receive the information(s), the Appellant preferred this Second Appeal before this Commission under Section 19(3) of the RTI Act, 2005 vide memo dated 27/11/24.

This appeal was, accordingly, listed today on 22.01.2025 wherein the appellant, Ms. Bengia Mama and Shri Yorum Sajan, Fishery Officer and APIO o/o the District Fishery Development Officer Yupia were present in person.

The Records also disclose that the F.A.A has not considered / adjudicated the appeal as mandated under section 19(1) of the RTI Act. As such, this Appeal was an appeal fit to be remanded to the First Appellate Authority (FAA), the Director (SJETA), Banquet Hall, Itanagar for adjudication. However, after hearing the parties, more particularly, the APIO, who submitted that the sought for information are ready to be furnished to the appellant, this Commission, decided to hear the appeal and pass necessary direction and accordingly, heard the parties.

The APIO submitted that some of the information are either repetitive or are not available with the PIO e.g, the records of PFMS are not held by the o/o the PIO. He, however, submitted that whatever documents are available with the PIO, the same shall be provided to the appellant.

This Commission, upon hearing the parties, directs the PIO to furnish to the appellant the sought for information which are available within a period of 1(one) week from the date of hearing and also furnish the specific reasons against whatever information not available. The appellant, shall, thereafter, intimate to this Commission her satisfaction of or otherwise with the information so received from the PIO.
