**Information sought :**

The appellant file a RTI Application dated 25/11/2024 seeking Details regarding Released of fund amount to Rs. 1038.56815 Lakhs of LOC for the month of March, 2024 to DFO Account NO. 31663915695 for proper implementation of of the items under CA, WLM & NPV component of the State CAMPA AOP Vol-i & ii during 2023-24 under the Department of Environment & Forest & Climate Change as per sanction order.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 09/01/2025. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

Respondent : PIO-cum- DFO, Yingkiong Forest Division attend through VC.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram, Shri Bengia Tahar and Shri Lokam Namdu on **25.11.2024** filed an RTI application under Form-'A' before the PIO-cum-DFO, Yingkiong Forest Division, Upper Siang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09.01.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **14.02.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 150/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 16/07/2025. In this hearing of the appeal on 16<sup>th</sup> day of July, 2025, the PIO-cum-DFO, Yingkiong Forest Division, Upper Siang attended through VC but the appellant Shri Riya Taram, Shri Bengia Tahar and Shri Lokam Namdu found absent without any intimation to the Commission.

The PIO has intimated that no any application under Form 'A' seeking information has been received from the appellant. As per the case record no acknowledgement is enclosed to show that an application has been filed seeking information from PIO. The appellant is directed to file a fresh application before the PIO.

The appeal case is disposed of accordingly.
