JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Potak Dubin, Near DC Office, Dokum Colony Daporijo, Upper Subansiri District Arunachal Pradesh**, for non-furnishing of information, by the **PIO –cum-EE, PHE&WS Daporijo Division, Upper Subansiri District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 18.04.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“JIM Scheme against Lingdam Village under Giba Circle for the duration 2022-2023.”

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on the 13th day of Sept'2023. The appellant was present. The representative of the PIO, Shri Hillang Raj (JE, PHE) was also present. After hearing both the parties, the Court directed the representative of the PIO to provide the information which can be done (such as DPR, TS, Tender-Agreement, etc.) as it is the ongoing project and the left-out information be provided on completion of the project on or before the next date of hearing of this case fixed on the 18th day of Oct'2023.

The 2nd hearing of this case was held on the 18th day of Oct'2023. The appellant was present. The representative of the PIO, Shri Khoda Sanjay (JE, PHE) was also present. After hearing both the parties, the appellant was directed by the Court to collect the information as sought from the PIO's office after paying the required fees through Treasury Challan and should go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 16th day of Nov'2023.

The 3rd hearing of this case was held on the 16th day of Nov'2023. The appellant was absent. The representative of the PIO, Shri Khoda Sanjay (JE, PHE) was present. The case was not heard owing to the absence of the appellant. Hence, the next date of hearing of this case was fixed on the 20th day of Dec'2023.

The 4th hearing of this case was held on the 20th day of Dec'2023. The representative of the PIO, Shri Khoda Sanjay (JE, PHE) was present but the appellant was absent. The appellant was found absent for 02 (two) consecutive hearings without any intimation for his absence. Therefore, it was presumed that he wasn't willing to pursue the case further. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
