**Information sought :**

The appellant file a RTI Application dated 25/10/2024 seeking Details regarding C/o Construction of Circuit House at Rupa , Phase-II against unspent amount.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 29/11/2024. No any hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum-EE(PWD), Kalaktang Division present in person.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **25/10/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Kalaktang Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from

the PIO, filed the First Appeal before the First Appellate Authority on 29/11/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 24/02/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 206/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 03/12/2025 and 02/02/2026. In this hearing of the appeal on 2<sup>nd</sup> **day of February, 2026**, PIO-cum-EE(PWD), Kalaktang Division, West Kameng District present in person but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

As per the case record, the information sought was provided to the appellant through registered post and through his personal whatsapp number. On the 1<sup>st</sup> hearing dated 03/12/2025, the appellant was directed to intimate to the Commission regarding the receipt of the information sent through registered post. The appellant was cautioned that if no intimation is made, the Commission will presume that the appellant has received all the information and is satisfied.

The appellant is found absent without any intimation though the Summon was sent well in advance through registered post and his personal whatsapp number. The commission presumes that the appellant has received all the information and is satisfied by the information provided.

Therefore, this Appeal No. APIC- 206/A/2025 is heard and disposed of and closed in his absence.
