**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Tadar Tai, Nyokum Lapang, Itanagar, Arunachal Pradesh, for non-furnishing of information, by PIO-cum-DPDO Koloriang, Kurung Kumey District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 28.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

***"1<sup>st</sup> and 2<sup>nd</sup> Installment release of Panchayat Bhawan/Common Service Centre C/o Panchayat Building and Community Hall under RASHTRIYA GRAM SWARAJ ABHIYAN (RGSA) Scheme in Kurung Kumey District of Arunachal Pradesh for the year 2019-2020 . "***

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing of this case was held on 01.03.2023. The appellant was represented by Shri K. Hano and the representative of the PIO Shri Chera Ngoya, District Nodal Officer PFMS(PR) was also present. Heard both the parties. The representative of the PIO has assured that the information as sought by the appellant would be provided on or before the next date of hearing of this case fixed on 26/04/2023.

The 2<sup>nd</sup> hearing of this case was held on 26.04.2023. Both the parties were absent. Hence the case couldn't be heard. Therefore, the Court has fixed the next date of hearing of this case on 10.05.2023.

The 3<sup>rd</sup> hearing of this case was held on 24.05.2023. Appellant was absent. But the representative of the PIO Shri D. Bengia DA was present. Therefore, the case couldn't be heard. The next date of hearing of this case was fixed on 14/06/2023.

The 4<sup>th</sup> hearing of this case was held on 14.06.2023. Appellant was present. The representative of the PIO Shri Chera Ngoya, DNO-PR was also present. Heard both the parties. The representative of the PIO has informed that the information as sought by the appellant would be provided within one week time and the appellant should go through the same after receiving the information and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 05.07.2023.

The 5<sup>th</sup> hearing of this case was held on 05.07.2023. Appellant was present. The representative of the PIO Shri Chera Ngoya, DNO-PR was also present. Heard both the parties. The representative of the PIO has brought the information as sought by the appellant and handed over to the appellant during the hearing of this case. The Court directed the appellant to go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 02.08.2023.

The 6<sup>th</sup> hearing of this case was held on 02.08.2023. The appellant was present. The representative of the PIO Shri Chera Ngoya, DNO-PR was also present. Heard both the parties. Appellant informed the Court that the information provided by the PIO in its previous hearing is in-complete on this the representative of the PIO appealed the Court that the list of left out documents/ in-complete documents be provided to him (PIO) so that the left-out information if any be provided to the appellant on or before the next date of hearing of this case. Later, the appellant was briefed by the representative of the PIO in details and clarified the doubts of the appellant on the information sought by him during the hearing of this case itself and accordingly the appellant on satisfaction of his doubts has pleaded for disposal of this case. Hence the case is disposed of.

**Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.**
