Information sought :

The appellant file an RTI Application dated 09/07/2024 seeking Details regarding Solid Waste Management on Engineering procuring and construction (etc) contract made at Pasighat.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 06/08/2024. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ngwazosa Yobin **09.07.2024** filed an RTI application under Form-'A' before the PIO-cum-ADC, Miao, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06.08.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 365/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2(two) times i.e on 12/03/2025 and 21/04/2025. In this hearing of the appeal on **21st day of April, 2025**, the PIO-cum- ADC, Miao, Changlang District found absent without any intimation to the Commission. The appellant Shri Ngwazosa is represented by learned Adv. K. Mibang.

The appellant has submitted a letter addressed to the State Information Commissioner stating that all the information as sought has been furnished by the PIO-cum-ADC, Miao and he is satisfied by the information provided. So he has requested for disposing off the appeal case NO. APIC-355/2024.

Request accepted and the appeal case is disposed off and closed.
