**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, C/o Post Office, Naharlagun, PO/PS, Naharlagun, Papumpare District, Govt. of Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Ziro II, CD Block Yachuli, Lower Subansiri District, Ziro, Govt. of Arunachal Pradesh Govt. of Arunachal Pradesh, as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 23/12/2022 regarding EXPENDITURE AND IMPLEMENTATION OF UNDER MG-NREGA ZIRO- II CD BLOCK YACHULI. SUPPLY OF WORK, M/S T.O. ENTERPRISES PERIOD 2020 TO TILL DATE.

The 3<sup>rd</sup> hearing is held today on 17<sup>th</sup> October, 2023 (Tuesday) as scheduled. Shri Gyati Pussang (Mob:- 9612560243) the SPIO-cum-BDO, Ziro II, CD Block Yachuli, Lower Subansiri District, Arunachal Pradesh alone is present and the Appellant Shri Tania June is found absent. During the 2<sup>nd</sup> hearing the Appellant was directed to collect the information by depositing the requisite fee from the office of SPIO. The SPIO has submitted that he has complied with the directions of the Commission and kept ready all the information. But the Appellant has not visited his office for collection of the information neither he has deposited the requisite fee as directed by the Commission. During the last hearing the Appellant was directed to appear before the court of the Commission in person failing which the case will be disposed of without further notice.

Considering the action taken by the SPIO and failure to comply with the directions of the Commission by the Appellant, the Commission arrives to its conclusion that the case shall be disposed of with the directions that Appellant to collect the information from the SPIO office by depositing the requisite fee.

Hence, the case is disposed of and closed.
