This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti Yukar Yaga, c/o Jullang near Sonam Nursery, Po/Ps-Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(WRD), Govt. of A.P., Water Resource Department, Raga Division, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/06/2023 regarding appointment of UDC/LDC/PEON/DRIVER/WCT/WCR/ Chowkidar/ All MTS Post of establishment.

The 4th hearing is held today on 11th June' 2024 (Tuesday) at 1030 hrs. Shri Dakbom Don, the PIO-cum-EE(WRD), Govt. of A.P., Water Resource Department, Raga Division, Kamle District, Arunachal Pradesh is present. The Appellant Shri Palen Laa is absent. The PIO has submitted that information sought for are not related to the EE (WRD), Raga, Kamle District. The appointments and recruitment are done from the office of the Superintending Engineer (Co-ord), WRD, Itanagar and does not relate to him. Accordingly, he has written a letter to the Appellant Vide No. RWRD/RTI-01/2020-21 Dated 17th August' 2023 heard all the reasons for non- availability of the information in his office.

The Appellant is absent for two consecutive hearings, he was directed to appear in the court in person failing to comply with the directions of the Commission shall disposed of the case and inspite of giving opportunity to him he does not appear in the hearing.

Hence the case is disposed of and closed.
