Previous Hearings:

First : 20.10.2023
 Second : 12.01.2024

Order of the second hearing: *"The commission has directed the appellant to collect the information from PIO's Office after depositing Rs. 62,214. In case the appellant is not satisfied with the information, he shall send a written submission explaining reasons for his dissatisfaction to the PIO with a copy marked to the commission. The said written submission of appellant expressing his satisfaction or dissatisfaction regarding the information must reach the commission on or before next date of hearing."*

The following were present.

Appellant : Present. He states that the calculation of amount of fee as already ordered in the 2nd hearing on

12.01.2024, may not be correct. So he sought 15 days' time to collect the information.

Respondent PIO

: Present through VC. He states that the information documents are ready to deliver to the appellant on his deposition of the requisite fee.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing and perusal of the records, observes that the appellant has not complied with the Commission's Order dated 12.01.2024. He is once again directed to deposit the fee as already ordered during 2nd hearing on 12.01.2024 and serve a copy of this order to the appellant and collect the information within 15 days from the date of issue of this order i.e on or before 11.02.2025.
