**SUMMON**

WHEREAS, in connection with the APIC-No. 34/2025, your personal appearance is required before the Commission on **29<sup>th</sup> July, 2025 at 02:30 PM**. The 1<sup>st</sup> hearing held on 1<sup>st</sup> May 2025. The Appellant Shri Mamu Sono, found absent during the hearing and PIO-cum-EE, **Power/Electrical, Bomdila Div. - (ii) To **summon** the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**

Due to absence of the both the parties, the Commission could not proceed the hearing of the appeal today.
