The 2<sup>nd</sup> hearing was held on 28<sup>th</sup> January, 2026 related to the APICs No-202/A/2025 & 203/A/2025(Appeal). PIO-cum-Divisional Forest Officer, Likabali Forest Division is represented by Counsel, Adv. L. Bui and the appellant Shri Tamchi Gungte present in person.

PIO has submitted a written petition in regard to APIC case No. 202/A/2025 stating that appellant was found absent for all the three hearings consecutively for the hearing conducted by the First Appellate Authority-cum-CCF, Pasighat by sidelining all important Govt. duties at Likabali, the appellant failed to appear.

The CCF-cum-FAA has written to the Commission regarding the case as citing that the appellant had been absent consecutively on the three occasions dated 27/01/2025, 06/02/2025 and 17/02/2025. Accordingly, the case was disposed of stating that the appellant has no genuine interest in seeking the information.

The PIO has also stated that there is no problem in giving the information to the appellant.

The appellant has stated that there have been multiple postponements of the hearings which he produced the postponement letters addressed to him.

The Commission directs the appellant to submit written reply to the Commission regarding the written submission made by the PIO for disposal of the case on the ground as decided by the First Appellate Authority. The appellant is directed to submit his petition on or before next date of hearing.

The Commission fixed next date of hearing on 30/03/2026 at 1030 hours.
