SUMMON

WHEREAS, in connection with the **APIC-No. 196/2025**, your personal appearance is required before the Commission on **13 November, 2025 at 10:30 AM**. The **1st hearing held on 5th August 2025**. The Appellant Shri Nabam Tapak, present during the hearing and the PIO was found absent without intimation to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO, besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI Act, 2005, Which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Court of the Commission that PIO has not furnished any of the information(s) as sought by him in his form 'A' application till date.

The Appellant requested that the Serial no.-7 of the Appellants form 'A' be amended from the word lies to list.

After hearing the Appellant, the Commission seriously viewed the absence of the PIO and ordered;

- i) To **summon** to the PIO, to provide all the information to the Appellant on or before the next date of hearing. and to attend the next date of hearing without fail. **Failing which, appropriate action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.**
- ii) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing. **Failing which his appeal shall be heard and determined ex-parte.**

Due to absence of the PIO, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

The next date of hearing be fixed on 13th Nov'2025 at 10:30 AM (Morning).
