An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-277/2025. (Summon to appear in person) (Or.5 R.3 of CPC)

ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Losik for non-furnishing of 23(twenty three) point information regarding State Own Revenue (SoR) Schemes in the entire Kurung Kumey District during 2022-23, 2023-24 by the PIO, o/o the District Panchayat Development Officer, Koloriang, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.09.2024:

This appeal was heard for the 3(three) times on 02.07.2025, 03.09.2025 and 24.09.2025.

On 02.07.2025, this Commission, upon hearing Shri Chera Tapung, Panchayat Technical Assistant (PTA), the District Nodal Officer (DNO) who appeared on behalf of the PIO and on noticing that the documents/information sought for by the appellant were not covered under the exemption provisions of the RTI Act 2005, directed the PIO and the DNO, vide interim order dt.04.07.2025, to provide the appellant the remaining documents within 3(three) weeks from 02.07.2025 i.e. on or before 23.07.2025 and also directed the appellant to intimate this Commission of the receipt of the documents.

In compliance with the aforesaid order of this Commission, the appellant, vide letter dt. 24.07.2025, had complained that inspite of this Commission's order dt.04.07.2025, the PIO has neither complied with the order nor given any reason for non-compliance of the order. He, therefore, pleaded for initiating necessary action under section 20(1) of the RTI Act and also under section 19(8)(b).

This Commission taking a serious view of the non-compliance of the order dt.04.07.2025 by the PIO, listed this appeal again on 03.09.2025. However, on 03.09.2025 also the PIO was absent without any intimation though the appellant appeared through VC who said that he had tried to contact the PIO a number of times through mobile phone regarding the left out information but the PIO did not pick up the phone.

This appeal was, thus, listed again listed and heard again on 24.09.2025 wherein the PIO Shri Nangram Pingkup, the DPDO along with Shri Chera Tapung, (PTA)-cum-District Nodal Officer (DNA) were present in person with the requested documents. The appellant Shri Bamang Losik was also present in person.

The documents brought in by the PIO were handed over to the appellant who was directed to go through the same and report his satisfaction or otherwise therewith within 1 (one) week for consideration of the appeal by this Commission, if required.

The Commission is now in receipt of letter dated 1st Oct. 2025 from the appellant Shri Bamang Losik intimating that he has received only partial information / documents from the PIO and pleaded for appropriate direction to the PIO to furnish the left out documents and also affidavit against those which are not available. The left out /remaining documents, among others, as contended by the appellant are:

However, it is made clear that if the o/o PIO does not hold any of the documents/information requested by the appellant, the PIO shall furnish a declaration to that effect in an affidavit as mandated by section-18(3)(c) of the RTI Act and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO shall comply with the above direction within 2(two) weeks from the date of receipt of this order and report compliance thereof on 12.11.2025, the next date of hearing.
