Take notice that in default of PIO's appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and Section 20 of the RTI Act, 2005 shall be invoked against the PIO and in case the Appellant remains absent the case would be disposed of without further any notice.
