**An Appeal Case U/S 19(3) of RTI Act, 2005**

**ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Chali Simit & Shri Ratan Chetia for non-furnishing of 7(seven) point information regarding teaching and non teaching staff under Education Department in various Schools and Offices in Namsai District by the PIO o/o the District Project Coordinator-Cum-PIO, ISSE, Samagra Shiksha District Society, Namsai, as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 07.12.2024.

**Hearing and decision:**

This appeal was heard on 25<sup>th</sup> July, 2025, wherein one of the appellants, namely, Shri Ratan Chetia and Shri Jumbom Gamlin, District Project Co-ordinator (DPC), ISSE representing the PIO were present through VC.

This Commission heard the parties and perused the points on which the appellants had sought the information / documents and found that they were not covered by any the exemption provisions. This Commission, therefore, directed the PIO to provide the information, as assured by him, to the appellant within one week from the date of receipt of the order and the appellant was also directed to intimate this Commission of the receipt of the documents and his satisfaction therewith within one week from the date of receipt of the documents for further consideration of the appeal.

One of the appellants, namely, Shri Ratan Chetia has now intimated vide letter dated 3<sup>rd</sup> August, 2025 that he has received the information from the PIO on 01.08.2025 but found that the information provided by the PIO is not complete as under:

(i)	Sl. No. 3 (01)	Working staffs (regular, casual, contractual, contingency) separately list not provided.
(ii)	Sl. No. 3 (02)	Information regarding advertisement not provided.
(iii)	Sl. No. 3 (04)	Information not provided as per form-A e.g., sanctioned strength and present strength.

The appellant has, therefore, pleaded for hearing the appeal again.



This Commission holds that it is the requirement of law that the requested information should be provided to the appellants to the satisfaction of the appellant unless exempted under the relevant provisions of section 8 or 9 of the RTI Act. As such the PIO is directed to provide the requested information to the appellants in complete and satisfactory form and report compliance thereof on or before 12.09.2025, the next date of hearing.
