**ORDER**

**The Commission hereby orders;**

- (i) The PIO to provide the information(s) to the Appellant pertaining only UC & Completion Certificate for SIDF/RIDF Schemes and firm details, on or before the next date of hearing as sought in his form 'A' application. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.**
- (ii) The Appellant to collect the information(s) from the PIO 's office on or before next date of hearing and convey to this Commission if he has received full information or not as applied, **failing which his appeal shall be decided without hearing him further.**
- (iii) The next date of hearing has been intimated to both the parties No formal notice required to be issued.
