ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri BamangLosik for non-furnishing of 23(twenty three) point information regarding State Own Revenue (SoR) Schemes in the entire KurungKumey District during 2022-23, 2023-24 by the PIO, o/o the District Panchayat Development Officer, Koloriang, KurungKumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.09.2024.

This appeal was last heard for the fourth time on 12.11.2025 and this Commission, upon perusing the documents brought in by the PIO's representative, Shri Durga Bengia, Computer-cum-Account Assistant, o/o the DPO, KurungKumey Distt, had passed the following order:

"The documents/information brought in by the representative of the PIO have been handed over to the appellant who went through the same during the course of hearing. This Commission also perused the point-wise replies /information furnished by the PIO vide letter dt.10.11.2025 whereupon it was noticed that the PIO had furnished the replies to almost all the points but there are still same points, as given below, against which replies/information have not been furnished:
