# ORDER

The 3<sup>rd</sup> hearing held on 1<sup>st</sup> July, 2024' related to the APIC No-340/2024. The Appellant Shri Riya Taram is present during the hearing. The PIO is represented by his PA, (Shri Bini Tare) during the hearing before the Commission.

### Heard the Appellant:

The Appellant stated before the Commission that he has not got any information(s) from the office of the PIO till date.

## Heard the representative of the PIO:

The representative of the PIO stated before the Commission that they are not aware of the Form-A application of the Appellant, but it is confusing also for that the same Form-A application is also being heard as an appeal in the court of a different Commissioner, to which the Commission put the onus on the representative of the PIO to authenticate. And the same Appellant has filed more than 12 (twelve) applications seeking different information(s) which makes the office unable to provide the information(s) to the Appellant in stipulated period of time as per the provision of RTI, Act, 2005, and the representative of the PIO requested the Commission for some more time so as to provide the information(s) which are available in the office of the PIO to the Appellant.

After Hearing both the parties and considering the request of the representative of the PIO: the Commission hereby orders as follows;

- The PIO to provide all information(s) sought completely to the Appellant on or i) before the next date of hearing.
- The PIO to produce proof as the Appellant has made appeal for the same set of ii) information(s) in different court of the Commission.
- Next date of hearing has been intimated to the parties. No formal notice required to iii) be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 30<sup>th</sup> September, 2025' at 2:30 PM (Evening)
