### WARNING SUMMON

**WHEREAS**, in connection with the **APIC-No. 1169/2023**, your personal appearance is required before the Commission on **18<sup>th</sup> November, 2025 at 02:30 PM**. The **3<sup>rd</sup>** hearing held on **7<sup>th</sup> August '2025**. The Appellant Shri Riya Taram, & Takam Sakap, absent during the hearing without intimating the reason for their inability to attend the hearing, to the Commission. It is worth mentioning that Appellants were absent in the **1<sup>st</sup>** hearing which was held on dated **12/11/2024** also today in the **3<sup>rd</sup>** hearing again Appellants are absent.

The PIO absent without citing reasons for his absence consecutively for the **3<sup>rd</sup>** time. It is to be mentioned that the PIO -cum EE (PHE& WS) was sent the notice of hearing on **17/09/2024** to be present on **12/11/2024** before the Court but the PIO was absent in the **1<sup>st</sup>** hearing on dated **12/11/2024**. The PIO was absent again in the **2<sup>nd</sup>** hearing held on **16/01/2025**, despite summons sent to him to be present in the hearing.

The PIO is absent again today despite summons issued to him, to be present today in the hearing. The PIO has not bothered to attend the hearing which signifies that he is not respecting the law of the Country and under such circumstances wherein the PIO's even after the Court notices and summons to attend Court hearings, fail to attend the hearing, compromises the functioning of the Court of the Arunachal Pradesh Information Commission(SIC).

**Therefore, the Commission hereby orders;**

- To **summon** the Appellants to be present in the next date of hearing, **failing which their appeal will be heard and determined ex-parte.**
- To **issue warning summons** against to the PIO-cum EE (PHE&WS) Roing Division, to attend the Court in the next date of hearing without fail, **failing which action will be initiated against him as per [provisions given under the RTI Act.2005.**
- Send copies of this order to both the parties and fix next date of hearing.

**The Commission hereby order;**

**The next date of hearing be fixed on 18<sup>th</sup> Nov'2025 at 1.30 PM (Afternoon).**
