- (i) To **summon** the Appellants to appear in person or through online mode before the Commission in the next date of hearing, **failing which their appeal shall be decided ex-parte.**
- (ii) The PIO to provide all the information(s) to the Appellants on or before the next date of hearing as sought in his form 'A' application. **Failing which action under section 25(5) shall be initiated against the PIO as per the provision of RTI Act, 2005.**

- (iii) A copy of this order shall be issued upon the Appellants and the PIO to ensure proper notification of this directive.

The next date of hearing been intimated to the representative of the PIO.
