In fourth hearing: "*The commission observes that the appellant has filed a written submission to the PIO on 25.09.2024 in compliance of this commission's interim order dated 05.09.2024. The PIO has not responded to the appellant. PIO, the Executive Engineer, PWD Sangram Division has remained absent in the last four consecutive hearings which appears to be a deliberate act, and is clear violation of implementation of RTI Act, 2005. It is decided to issue show cause notice to the PIO, the Executive Engineer, PWD Sangram Division as to why penal action as per provision in the RTI Act, 2005 should not be imposed to him under intimation to the Public Authority who can take action to the PIO - the Executive Engineer, PWD Sangram Division and ensure implementation of RTI Act,2005*".

Relevant facts emerging during hearing:

The following were present:

Appellant : Present. He states that the PIO has not furnished the information irrespective of repeated order issued by this commission court including a show cause notice. He further states that former PIO – Shri Nangbia Tada, EE is replaced by other person on transfer / revert of Shri Nangbia Tada and current PIO has assured to him verbally to furnish the information.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstance of the case, hearing the parties and perusal of the records, observes that PIO, EE, PWD Sangram Division has not complied interim orders of this commission court. The PIO has not responded the **SHOW CAUSE NOTICE** dated 17.12.2024 issued to him.

Considering time constraint at the time of financial year end and as the current PIO has assured verbally to the appellant to furnish the information and in the absence of the PIO in today's hearing, the PIO is given one more time for furnishing the information before imposition of penalty under Section 20 (1) of RTI Act, 2025. The PIO is directed to furnish the information to the appellant on or before **20th April 2025.**

Next date of hearing shall be fixed in due course of time.


