ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 19 (nineteen) point information on c/o "M R Lo1- Akajan Likabali Bam Road to Govt. Model Degree College, Basar under Pradhan Mantri Gram Sarak Yajana" during the financial year of 2023-24 by the PIO, o/o the Executive Engineer (RWD), Basar Division, Leparada District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.05.2025.

This appeal was heard 2(two) times earlier on 03.12.2025 and 30.01.26. On 03.12.25, wherein both the appellant, Shri T. Gungte and the PIO, Er. Karbom Basar, EE, Basar RWD Division were present in person, this Commission after hearing the parties and on perusal of the the appellant's complaint for not furnishing the complete information by the PIO, directed the PIO to furnish to the appellant all the left out information/documents except in respect of Sl.No.9 and 13 (which were not pressed by the appellant) as early as possible and report compliance thereof to this Commission on 30th January, 2026.

On 30.01.2026, the appellant was present in person while the PIO was represented by Er. Shri Taba Riba, AE-cum-APIO with the left out documents/information which were handed over to the appellant with the direction to go through the documents/information so furnished by the o/o the PIO and report his satisfaction or otherwise therewith to this Commission within 1(one) week from the receipt of this order.

As directed the appellant A letter dt. 2nd February, 2026 has complained as under:

"Respected Sir,

With due respect, I would like to inform you sir that the documents furnished by PIO is incomplete as I have seek in my Form-A and I believe that the information I'm seeking doesn't fall under section 8 of the RTI act.

Following are details of the incomplete information as per my Form-A: -

- A. Serial no. 2: The document is furnished is not clear.*
- B. Serial no. 4: The information is furnished is incomplete as per the progress of the work.*
- C. Serial no. 5: the documents is not furnished.*
- D. Serial no.6: the documents is not furnished.*
- E. Serial no. 10: the documents is furnished is incomplete as there is no drawing of the Detail Cross Section of the road.*

- F. Serial no. 12: the documents is not furnished.
G. Serial no. 13: The documents is not furnished.
H. Serial no. 10: No documents of the other tender participant.
I. Serial no. 13: No documents of the other tender participant.
J. Serial no. 15: No documents is furnished.
K. Serial no. 16 & 17:-the documents furnished is not visible.
L. Serial no. 18: the documents furnished is incomplete as there is no documents of other participant.
M. Serial no. 19: There is no documents provided as I seeked in my form-A.
N. Serial No. 20: There is no documents provided as I seeked in my Form - A
O. Serial no. 21: the documents is not furnished.
P. Serial no. 22: the documents is not furnished.
Q. Serial no. 26: no information furnished.
R. Serial no. 27: no information furnished.
S. Serial no. 29: no information furnished.

In the premises as above, the PIO is directed to furnish the left out information as mentioned above to the appellant and report compliance therewith on 20.03.2026 the next date of hearing so as not to constrain this Commission the invoke the penal provisions of the RTI Act, 2005.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
