- ii) PIO to provide complete information(s) to the Appellant on or before the next date of hearing.
- iii) Copy of this order need not be given to the Appellant as he is present in person during the hearing.

The next date of hearing be fixed on 23<sup>rd</sup> September, 2025' at 2:30 PM (Evening).
