The 8th hearing was held on 6th August, 2025 related to the APIC No-143/2023 & APIC-342/2024 (Appeal). Both the parties the PIO-cum-EE(PWD), Sangram Division and the appellant Shri Riya Taram found absent.

The present case was taken by the Hon'ble State Information Commissioner Shri Dani Gambo and conducted few numbers of hearing. Later on the Hon'ble State Information Commissioner recuse himself to conduct further hearing of the case as he had been in the same department as Chief Engineer.
