### **SUMMON**

WHEREAS, in connection with the <u>APIC-No. 112/2025</u>, your personal appearance is required before the Commission on 31<sup>st</sup> July, 2025 at 10:30 AM. The 1<sup>st</sup> hearing held on 6<sup>th</sup> May' 2025, related to the APIC No-112/2025. The Appellant is represented by Adv. Domo Boje, during the hearing but PIO-cum DMO Daporijo found absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

## Heard the representative of the Appellant.

The representative of the Appellant stated before the Commission that PIO has provided all the information(s) as sought by in his form'A' application but only **serial no (a) Answer Script/Answer Sheets** of all the selected candidates and wait listed candidates have not yet been provided till date.

## The Commission hereby observes;

In the absence of the PIO the facts could not be ascertained for which a fair chance for the PIO to be heard be given in the next hearing.

The Commission seriously viewed the absence of the PIO and hereby orders;

- (i) To <u>summon</u> the PIO to appear in person or through online mode before the Commission in the next date o hearing. Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.
- (ii) The PIO to provide all the information(s) pertaining to serial no. (a) as sought in his form"A' application. Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.
- (iii) The hearing notice need not be send to Appellant as his representative present during the hearing.

The next date of hearing be fixed on 31st July 2025 at 10:30 AM (Morning)
