<u>ORDER</u>

The 1st hearing held on <u>6th February, 2025'</u> related to the <u>APIC No-348/2024</u>. The Appellant Shri Riya Taram is present during the hearing. The PIO is represented by APIO, (Shri Dominic Bake) during the hearing before the Commission.

Heard the Appellant:
