ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Bengia Tahar and Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Sangram Division, Kurung Kumey District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 22.08.2024.

A. Particular of information: Information against the State infrastructure Development Fund (SIDF) 2020-2021

B. Details of information:

1. The List of Scheme.

- 2. The Name of Work List with Geotag Report/ Sanction Order/Technical Sanction (TS) order copy.
- 3.Details of Project Report (OPR)/Estimate copy.
- 4. The List of Work Order copy with Cheque book counterfoil/leaf /demand draft /Banker Cheque /deposited slip/Challan and PFMS Transaction details as according to the Amount which Mentioned in Work Order/Sanction Order/Name of work list.
- 5.Name of Contractors/Firm/ Enterprise with their bank account number.
- 6.The deposited Slip/Voucher/Treasury Challan of GST Amount/Money which deposited to Govt. Account against Royalty by Firm/Enterprise account with GST updates.
- 7.Xerox copy of all the Trading License/Firm/Enterprise.
- 8.The Deposited slip/Challan /voucher/Transaction of GST Money deposited to Government Account against Royalty by Executive Engineer, division Account /Firm/ Enterprise Account and also Mention the Owner Name of firm / enterprise / Proprietor Name. Give reason What Firm /Enterprise Owner/Proprietor is to AE / JE who run the Firm /Enterprise ?
- 9. Details of Payment with Money Receipt of Contractors/Firm/Enterprise.
- 10.Bank Account Statement of EE Division with its Account Number.
- 10. Dank Account Statement of ED Druster which wrote to the Branch Manager of State Bank of 11. The Letter/petition/LOC/LOA which wrote to the Branch Manager of State Bank of India to Released of Fund to Executive Engineer Account by Chief Engineer PWD.

12.Measurement book (MB) with page number/Hand Receipt and Payees Name.

12.Measurement book (WB) with page number runner and page number runner runner and page number runner runner

This Commission perused the list of documents as contained in the aforesaid letter of the PIO, the E.E (PWD), Sangram Division and found that the information/documents brought in by the representative of the PIO were, indeed, not complete as per the list contained in the RTI application of the appellant. It was found that against number of points, the PIO had mentioned either 'not found' or 'not available' while against some of the points, the PIO has stated 'it shall be furnished'.

The appellant expressing his disappointment over the absence of PIO in the hearing pleaded that instead of deputing his PA or other staff he should attend the hearing to explain the reasons for furnishing the incomplete / misleading information, thereby violating the provisions of RTI Act.

This Commission, upon hearing the parties and on perusal of the documents brought in by the representative of the PIO, directs the PIO to furnish:

- all the left out documents such as, among others, the copy of Tradding Licence of the firms, copy of sanction orders, the MB as per the work order and amount paid to individual firm separately, the details of deduction made against GST/Royalty, the copy of LOC/LoA issued to the SBI by the CE, the cheque counterfoils or the RTGS/NEFT records of payment made to the firms/ enterprise separately, Money Receipts, the work completion certificate by the EE concerned;
- declaration by way of an affidavit with cogent reasons in respect of the documents / information which are not available with the PIO in terms of rule 5(vi) of the A.P Information Commission (Appeal Procedure) Rules, 2005.

The PIO shall comply with the above direction with intimation to this Commission within 3(three) weeks from the date of receipt of this order, whereafter the next date of hearing, if required, shall be fixed.
