SUMMON

WHEREAS, in connection with the **APIC-No. 649/2025**, your personal appearances required before the Commission on **24th February 2026 at 01:30 PM**. The 1st hearing held on **16th October' 2025**. The Appellant Shri Lajamang Mannow is present during the hearing before the Commission.

The PIO of the Office of the Chief Engineer (SE), Coordination, PWD, Mowb-II, Itanagar, Papumpare District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

The PIO is absent despite notice of hearing served unto him from the Commission on 24th day of September' 2025.

In the absence of the PIO the hearing of this appeal could not proceed so the Commission fixed another date for hearing.

After hearing the Appellant and going through the Form-A application of the Appellant, the Commission hereby orders;

- i) To send summons to the Superintending Engineer (SE) to be present in the next date of the hearing without fail, failing which necessary action as per the provisions of RTI Act, 2005 will be initiated against the PIO-cum-SE, PWD, Mowb-II, Itanagar, Govt. of Arunachal Pradesh.
- ii) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.

- iii) Notice need not be issued to the Appellant for the next date of hearing as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 24 February' 2026' at 1:30 PM (Evening).

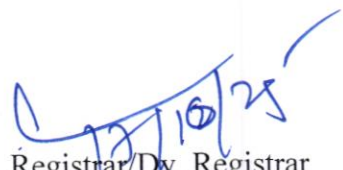
