SUMMON NOTICE.

The 2nd hearing was held on **21st January 2026** related to the **APIC No- 521/A/2025(Appeal)**.
PIO-cum-DPO, Basar, Leparada District attended the hearing through VC and the appellants Shri Nyake Bojir and Dedak Gadi present in person.
