**SUMMON**

The **3rd** hearing held on **30<sup>th</sup> January, 2025**, related to the **APIC No-225/2024**. The Appellant Shri Tai David, present during the hearing. The PIO-Cum- Executive Engineer (PHE), Itanagar found absent during the hearing without intimating to the Commission for the reasons of his inability to attend the hearing.

**Heard the Appellant.**

The Appellant stated that the PIO has provided some of the information that which he applied regarding details of information sought by the Appellant under Sl.No. (1) i.e. 90 nos of details of DPR are yet to be provided to him and the copy of the sanction order in Sangdopota Circle, in Sl No. (3) the application of the Appellant is not clear as to what he wants. So it is amended as to provide payments made to the contractor in tender or non-tender works and the payments detailed list.

During the last hearing the PIO, stated before the Commission that the information sought by the Appellant under 2,3,4 & 5 are of the entire circle and there are lots of scheme covering 91 villages though the information sought are for one year 2023 -2024. The PIO stated that before the Commission that the information sought by the applicant are very voluminous and requested the Commission as well as Appellant for giving them two months time to prepare the information. To be provided to the Appellant.

Due to absence of the PIO, the Commission could not proceed the hearing of the appeal and ordered;

- (i) To **issue summon** notice to the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide rest of the information(s) to the Appellant on or before next date of hearing. ***Failing which action which section 25(5) shall be initiated against the PIO as per the provisions of RTI Act, 2005.***

- (iii) Next date of hearing has been intimated to the Appellant, notice need not be issued to the Appellant.
