ORDER

Heard the APIO:

The APIO stated before the Commission that all information(s) have been furnished to the Appellant with sign of the PIO.

Heard the Appellant:

- (i) The PIO to provide the information(s) with seal and sign of the PIO to the Appellant within a week time with CTC on every page, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (ii) Next date of hearing has been intimated to both the parties. No formal notice required to be issued.
