**WARNING SUMMON**

**WHEREAS**, in connection with the **APIC-No. 946/2023**, your personal appearance is required before the Commission on **18<sup>th</sup> November, 2025 at 02:30 PM**. The **3<sup>rd</sup>** hearing held on **7<sup>th</sup> August 2025**. The Appellants Shri Riya Taram, & Takam Sakap absent during the hearing without intimating the reason for their inability to attend the hearing, and the PIO-cum EE (WRD) Pasighat District Siang Govt. of Arunachal Pradesh, found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend the Court when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

In the absence of both the parties the Commission here by observes that in the **2<sup>nd</sup>** hearing held on **16/01/2025** the PIO stated before the Court of this Commission that the information(s) sought by the Appellants are ready to be furnished to the Appellants upon payment of **Rs 11,210 ( Rupees Eleven thousand two hundred ten) only**.

The Commission is not clear as to the Appellants have paid the requisite fees as mentioned by the PIO and received the information(s) or not.

In the absence of both the parties nothing could be decided so the Commission hereby orders;

- The Appellants to be present in the next date of hearing fixed without fail, **failing which this instant appeal will be heard and determined ex-parte.**
- To issue summons** to PIO -cum EE (WRD) East Siang Pasighat Division to be present in the next date of hearing fixed to ascertain the fact that the information have been furnished to the Appellants or not.
- Send notice to both the parties for the next date of hearing be fixed on **18<sup>th</sup> Nov'2025**.

**The next date of hearing be fixed on 18<sup>th</sup> Nov'2025 at 1.30 PM (Afternoon).**
