**ORDER**

The 2<sup>nd</sup> hearing held on **13<sup>th</sup> February 2025**, related to the **APIC No.739/2023**. The Appellant Shri Tamchi Gungte absent during the hearing with a letter of absence submitted to the Commission citing the reason for his absence which the Commission took note of.

**Heard the PIO**

The PIO –Cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri found absent without intimating the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI, Act 2005, which is a statutory duty binding upon the PIO.

In the absence of both the parties the hearing could not be proceeded on with and therefore.

**The Commission hereby orders;**

- (i) **The summon** was issued to the PIO on 3/12/2024 to be present in the hearing today. That, despite being served summons to the PIO he has failed in attending the hearing signifying disrespect to the order of this court.
- (ii) In the absence of both the parties the hearing of the appeal could not be proceeded, so the hearing is adjourned to be posted to another date.
- (iii) To **issue bailable arrest warrant** to the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri to ensure his attendance in the next date of hearing.
- (iv) To serve the copy of the bailable arrest warrant to Officer in-charge (OC) of Daporijo to execute and return the arrest warrant on the next date of hearing.
- (v) The order copy of the bailable arrest warrant be served to the SP Upper Subansiri, for compliance.

**The Commission hereby orders;**

**Next date of hearing is fixed on 13<sup>th</sup> May, 2025 at 2.30 hrs. (Afternoon)**


