SUMMON

WHEREAS, in connection with the **APIC-No. 771/2023**, your personal appearance is required before the Commission on **10th February, 2026 at 01:30 PM**. The **4th** hearing held on **14th October, 2025**. The Appellant Shri Tamchi Gungte is absent without intimating the Commission the reason for his inability to attend the hearing.
