#### SUMMON

**WHEREAS**, in connection with the APIC-No. 725/2025, your personal appearances required before the Commission on **23<sup>rd</sup> April 2026 at 10:30 AM**. The 1<sup>st</sup> hearing held on 22<sup>nd</sup> January' 2026. The Appellant Shri Donik Roru, present during the hearing and PIO-cum EE (RWD) Palin Division, Kra -Daadi District, is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

**The Commission seriously viewed the absence of PIO and hereby orders;**

- i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per provisions of RTI Act 2005.**
- ii) The Appellant to be present in person or through online mode before the Commission in the next date of hearing. Without fail. **Failing which this appeal shall be heard and determined ex parte.**

**Due to absence of PIO, the Commission could not proceed the hearing of the appeal.**
