**An Appeal Case U/S 19(3) of RTI Act, 2005**

**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.06.2025:

**A. Particulars of the Information:** Under Budget Estimate (BE) 2024-2025.

1. School building for Govt. Sec. School Sali, Kurung Kumey under BE 2024-25;
2. c/o Damin ADC HQ. township road (CMCSRQP-II) under BE 2024-25;
3. c/o Patuk ADC HQ. Township road (CMCSRQP-II) under BE 2024-25;
4. c/o bridge over Pado river between Parsi Parlo to Pado Village with approach road (span 20m) (CMCSRQP-II) under BE 2024-25;
5. c/o road from Parsi Parlo Helipad Ground to CO office and Township road in Kurung Kumey District (CMCSRQP-II) under BE 2024-25 and
6. c/o road from Bigo Village to Parsi Parlo CO HQ. in Kurung Kumey District (CMCSRQP-II) under BE 2024-25.

**B. Details of Information required**

- i. Work order by particular name/firm;
- ii. DPR;
- iii. Technical Sanction order copy (TS);
- iv. Acceptance Letter;
- v. Commence Letter;
- vi. Technical Bid;
- vii. Tender Agreement copy and
- viii. Details building plan for Building Project.

**Period for which information asked for: 2024-2025**

Facts emerging from the appeal disclose that the appellant, Shri Bamang Pacho had requested the PIO, o/o the EE (PWD), Sangram Division for the aforementioned information / documents but failed to obtain the same which prompted him to file his 1<sup>st</sup> appeal before the Chief Engineer, (PWD), Central Zone-A, Itanagar, Govt. of A.P, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 18.07.25.

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, AP, Itanagar conducted hearing on 20.08.25, wherein the appellant Shri Bamang Pacho was present but the Respondent PIO was absent, and passed the following order:

*"In accordance with the hearing notice dated 30/07/2025, the appellant is present but the respondent PIO is absent for the case hearing on RTI 15 appeal received on 22/07/2025 regarding non furnishing of documents by PIO cum Executive Engineer, Sangram Division, PWD against two applications demand are same in both the applications. The PIO is contacted over phone and he is ready to provide the documents. The absence of PIO or any representative of him for the case hearing is taken seriously by the undersigned.*

*Therefore, the respondent PIO is directed to furnish the sought information within 20 days from the date of issue of this order with intimation to this office.*

*Accordingly these two cases stand disposed of with liberty to the appellant to prefer second appeal to the State Information Commission as per section 19(3) of the RTI act.*

However, the appellant, apparently failed to obtain the information yet again and thus preferred his 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt12.09.2025

This appeal is accordingly, listed today on 13.02.2026 wherein the appellant Shri Bamang Pacho and Shri Bini Tare, i/c RTI Cell representing the PIO, the EE ( Sangram Division), are present.

Heard the parties.

The representative of the PIO submitted that consequent upon bifurcation of Koloriang Division from the Sangram Division the handing over and taking over of the charge of the Koloriang Division has been done on 14.10.2025 and that consequently for the pending RTI cases till 14.10.2025 in respect of the Koloriang Division, the EE (Koloriang Division) be summoned. The representative, however, did not produce any supporting Govt. order as to the handing over of the charges including the RTI case.

In the premises as above, *this Commission deems it appropriate to summon the PIOs of both the Sangram Division and Koloriang Division in the next date to hear them and decide as to whose Division shall provide the requested information.*

**NOW THEREFORE**, the EE-cum-PIO, Sangram PWD Division and the EE-cum-PIO, Koloriang PWD Division are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 18.03.2026 (Wednesday) at 10:30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
