SUMMON

WHEREAS, in connection with the **APIC-No. 239/2025**, your personal appearance is required before the Commission on **18th September, 2025 at 10:30 AM**. The 1st hearing held on 10th June' 2025, related to the **APIC No-239/2025**. The Appellant Shri Mamu Sonu found absent during the hearing but intimated the reason for his absence to the Commission and PIO-cum EE, Power (E) Bomdila Division West Kameng District, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and the Commission hereby orders;

- (i) To **issue summon** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- (ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

The next date of hearing be fixed on 18th Sept 2025 at 10:30 AM(Morning).
