ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Benagia Tani G- Sector Naharlagun, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Executive Engineer (PWRD) Sangram Division District Kurung Kumey , Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/11/2023 regarding **the below listed information(s)**.

1. The 5th and final hearing is held on 5th June 2025 The PIO-cum Executive (PWD) Sangram Division District Kurung Kumey, Arunachal Pradesh, is absent without intimating the reason for his inability to attend the hearing. The Appellant Bengia Tani appeared before the court through Video Conferencing.
2. The Appellant stated before the Commission that he has not received any of the information from the PIO till date.
3. The Commission observed that on the last hearing held on 20th March 2025 The Executive Engineer (PWD) Sangram Division District Kurung Kumey, Arunachal Pradesh was directed to furnish the information(s) sought in the form A' application of the Appellant listed under 1,2,3 and 5 only to which the PIO also agreed..
4. The PIO did not appear before the Court in person in the fifth and final hearing and also the PIO has not provided the complete information to the Appellant. The willful absence is violation of provisions of the RTI Act and non-compliance of directions of the Commission has been viewed as breach of fundamental right of a citizen and contempt of court.

Observation and orders;

Considering the matter judiciously, the Commission hereby impose a **penalty of Rs. 25, 000/- (Rupees twenty five thousand) only against The PIO-cum- Executive Engineer (PWD) Sangarm Division Kurung Kumey District, Arunachal Pradesh** for gross violation of the provisions of RTI Act 2005. The PIO is directed to deposit the said penalty amount in favour of the Registrar, Arunachal Pradesh Information Commission, Itanagar through Treasury Challan under the Head of Account "0070-Other Administrative Charges"

The penalty amount be deposited before 30th June 2025 and the proof of depositing the amount through treasury challan along with all the information as sought by the Appellant has to be produced on the next date of hearing, failing which additional action shall be initiated under Section 20(2) of the Act i.e. recommendation for disciplinary action under the provisions the RTI Act 2005. The Appellant is also directed to be present in the next date of hearing, failing which the case would be decided ex-parte.

The next date of hearing is fixed on 16th Sept 2025 (Tuesday) at 2.30 PM.


