Summon Notice.

The 5th hearing of APIC-316/2023 is held on 22nd January, 2024. Both the parties found absent during the hearing. However, the appellant Shri Nikam Dabu detailed his representative namely Shri Tasi Chader. But the PIO failed to intimate reason of his absent during the hearing.

After going through all the records & Documents, the Commission found that the PIO failed to deposit the penalty to the **head account no. '0070'** and compensation to the appellant as per the last order passed by the Commission on dated 04/12.2023. Moreover, the PIO failed to furnish the information to the appellant till date.

On this, the Commission viewed seriously on the reluctant attitude of the PIO and directed to deposit penalty to the **head account no. '0070'** and submitted the treasury challan to the Commission office immediately and also compensate the said amount of compensation as mentioned in the order, to the appellant on or before next date of hearing. Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005.

Therefore, the Commission directed to issue last warning summon notice to both the parties for their personal appearance before the Commission in the next date of hearing. And also WT message be sent through the Deputy Commissioner, Daporijo, U/Subansiri District to direct the PIO to present in person before the Commission in the next date of hearing and the PIO is also directed to furnish all the information correct, readable and authentic as sought by the Appellant in his Form 'A' application on or before next date of hearing. If the PIO failed to furnish the information on or before next date of hearing. Failing which Section 20 (2) shall be initiated against the PIO as per the RTI Act, 2005.

The appellant also if he failed to appear before the Commission in the next date of hearing his appeal shall be decided as ex-parte & disposed of.

The Commission fixed the next date of hearing on **8th April, 2024 at 1030 Hours.**
