<u>ORDER</u>

The 3^{rd} hearing held on <u>4th March' 2025'</u> related to the <u>APIC No-570/2023</u>. The Appellant and the PIO both are present during the hearing before the Commission.

Heard the PIO:

The PIO stated that he has brought information(s) sought by the Appellant.

Heard the Appellant:

The Appellant stated that the sets of information(s) have not been compiled properly for which the PIO apologised to the court stating further that any information(s) that has been left out will be furnished to the Appellant on or before the next date of hearing.
