ORDER

The 2nd hearing held on 11th February' 2025, related to the APIC No. 1149/2024 (Appeal). The PIO-cum- Chief Engineer (CE) Rural Works Department (RWD) Western Zone Itanagar, Govt. of Arunachal Pradesh, and the Appellant Shri Tania June both are absent during the hearing without intimating to the Commission the reason for their inability to attend the hearing.

The Commission viewed seriously on the absence of both the parties and Commission hereby orders;

- (i) To *issue summon to the Appellant* to present in person or through online mode before the Commission in the next date of hearing, **failing which his appeal shall be decided ex-parte.**
- (ii) To issue summon to the PIO to furnish all the information to the Appellant on or before next date of hearing. Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005. And to be present the next date of hearing in person or through online mode, which the appeal shall be heard and decided in his absence.
- (iii) Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission hereby orders;

The next date of hearing fixed on 17th April '2025 at 10.30 AM (Morning).
