ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bengia Tahar for non-furnishing of below mentioned information by the PIO, o/o the (DLRSO), East Kameng District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.06.2025:

A) Particular of information: To furnish all the relevant information against Arunachal Frontier Highway viz. 1 Lada to Sarli the District along with all project Affected families (PAFS) and realistic land owners from 2024-2025.

B) Details of information required:

1. Furnish the Sanction Order copy of Land compensation.
2. Furnish the Land Acquisition Notification copy.
3. Furnish the Land Compensation assessment copy of CD Block/village wise.
4. Furnish the Claim and Objection of Land Acquisition and Compensation Notification copy.
5. Furnish the Selected List of Affected Land Owners/Beneficiaries in village wise with their Contact Number/Adhaar Card/Voter ID Card/PRC/Recent Pass Port Size Photo-3 Account number & IFSC Code/A duly Signed affidavit/Deed of Acceptance.
6. Furnish the Copy of Deed of Acceptance which might be duly Signed by Chairman Disbursement Board and other members with mention the Name of Officers with their designation.
7. Furnish the Bank Account Number of all the Genuine Land Owners with details records transferred amount to the Land Owner through DBT.
8. Furnish the Order copy & final Resolution of meeting with meeting attendance List.
9. Furnish the Technical Sanction (1S) Copy of all the above Mentioned Project.
10. Furnish the First & Final Bill copy of all the Materials/Areas of affected Land.
11. Furnish the Money Receipt/Payment list of affected Land Owners with their Contact Number/Adhaar Card/Voter ID Card/PRC/Recent Pass Port Size Photo-3 Account number & IFSC Code/A duly Signed affidavit/Deed of Acceptance.
12. Furnish the details of payment mood like xerox copy of Cheque Leaf/pay in slip for NEFT/ RTGS/ PFMS details records of Direct Benefit Transaction (DBT) to the Land owners/ Beneficiaries Account from joint Account of Deputy Commissioner and DLRSO. Give the account No. of DC & DLRSO.
13. Give the name of officer and Officials who executed the work & disbursement the payment to the land owner.

Facts emerging from the appeal:

Records in the appeal disclose that the appellant, Shri Bengia Tahar had requested the PIO, the DLRSO, East Kameng District, Seppa for the aforementioned information / documents. But having failed to obtain the information, he filed his 1st appeal before the Deputy Commissioner, the First Appellate Authority (FAA) under section 19(1) of the RTI Act, 2005 vide his Memo of Appeal dt.20.08.2025.

The records further reveal that the FAA had conducted the hearing on 26.09.2025 and passed order dt.26.09.2025 as under:

"ORDER

Respondent PIO-Cum-DLRSO, East Kameng District, Seppa and Appellant both were present in the Hearing.

Respondent has conveyed that they will furnish the required information within 14 (Fourteen) Days.

Therefore, PIO-Cum-DLRSO, East Kameng District, Seppa is hereby directed to furnish the seeking information/documents to the Appellant within 14 (Fourteen) Days from the date of issue of this Order without fail.

The Case is hereby kept in pending till providing of the information sought for within 14 (Fourteen) Days from the date of issue of this order.

The appellant, however, apparently failed to receive the information from the PO. Hence, this 2nd appeal before this Commission which has been listed today on 13.02.2026 wherein the appellant, Shri Bengia Tahar is present in person while the PIO is absent without any intimation though the AC-cum-APIO, o/o the DC, East Kameng District, vide her letter dt.19.01.2026, had requested the PIO, the DLRSO to attend the hearing.

Heard the appellant who, reiterating his demand for the sought for information from the PIO, pleaded for an appropriate direction to the PIO to furnish the information besides stringent action against the PIO for his non-appearance in the hearing.

The absence of the PIO, without any intimation, despite summons, has been viewed seriously by this Commission.

This Commission perused the points on which the appellant has requested information/documents and it is noticed that the information/documents sought for are not covered under the exemption provisions of the RTI Act, 2005 and in view thereof the PIO o/o the DLRSO, East Kameng District, Seppa is directed to furnish the requested documents/information to the appellant in right earnest and report the compliance thereof / action taken thereof on 18.03.2026 the next date of hearing.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 18th March, 2026 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
