SUMMON.

The 1st hearing held on **6th February 2025**, related to the **APIC No. 130/2024 (Appeal)**. The representative of the PIO Shri Sachin Jerang, present during the hearing through online mode. The Appellant Shri Mamu Sono, found absent without intimating to the Commission the reason for his inability to attend the hearing.

Heard the representative of the PIO.

The representative of the PIO stated that information(s) are very voluminous spanning to 15 years, as sought by the Appellant in his form 'A' application. The representative of PIO has requested to the Commission as well as the Appellant to give him more time to prepare the said information(s) and the Appellant to be specific and abridge the information(s) which he would prefer to be given on priority amongst the information(s) as applied by him, to ease the office of the PIO to render other public services to the public.

- (ii) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application. **Failing which necessary action shall be initiated against the PIO as per the provisions of RT I Act 2005.**
- (iii) The next date of hearing has been intimated to the representative of the PIO as he is present in the hearing. The hearing notice be sent to the Appellant as he is absent in the hearing.
