The 3rd hearing held on 7th August' 2025' related to the APIC No-829/2023. The Appellant Shri Palen Laa is present.

2. The Appellant to contact the office of the PIO for getting the complete information(s) and also to be present in the next date of the hearing without fail, failing which this instant appeal will be heard and determined Ex-parte.

The Commission hereby orders;

The next date of hearing be fixed on 18th November, 2025' at 1:30 PM (Evening)
